Rental conditions Alois Praschberger – Rolltechnik & Sport GmbH rents the equipment based on your rental order as well as the general terms- and rental conditions. By the renting you confirm the information and the approval from this conditions and insure, that you follow them strict.

### 1. Transference

The rights and responsibilities from this rental order are not transferable. The rented equipment is property from Alois Praschberger – Rolltechnik & Sport GmbH and only you are allowed to use this.

Any transference or sublease rentals through another person is not allowed and ineffective.

### 2. Responsibility

The use of the rental equipment take place at the user's own risk.

The hirer is not financially liable for loss or damages,

which a user any other person on the other,

things or the own person property during the rent to hurt.

The lessee/user shall be liable exclusive.

The rental equipment is uninsured.

Any damage at the equipment as a result of inappropriate handling

is not covered by that fee and will be charged extra.

Please keep the original packaging for the return transport.

The rental equipment must be ready packed for collection.

To avoid accidents, we recommend wearing a safety helmet!

We recommend the visit on a skiing lesson for beginners.

### 3. Payment

The payment is to be made on our bank account in advance.

If you pay the rental costs per PayPal or credit card you get an extra charge of 3 %. A reservation is only confirmed when the amount payable is on our bank account. The rental costs must be paid at latest a week before renting the equipment. Only the rental costs on our website [www.praschberger.com](http://www.praschberger.com) count for the desired equipment. The rental costs include the legal VAT and the full range is to pay in EURO.

If the payment is in a foreign currency, the charges from the exchange rate are to be consider by you.

The rent for the equipment is for the complete rental period. The rent can't be refunded for days you don't used because of bad weather, illness...

While the renting other costs can arise by the using of the equipment because of damages on the equipment, loss, stealing or charges for belated return.

#### **4. Delivery**

Alois Praschberger – Rolltechnik & Sport GmbH offers you the equipment as well as some other accessories in a good overall condition ready for use.

You commit that the equipment is returnable in the same state as by the renting, subject to possible wastage, including accessories inside of our business hours within the time stated in the rental order. You can pick up and bring back the equipment outside of our business hours after an agreement too. For this case you take the whole responsibility.

If you miss to bring back the equipment at the agreed day, for every other day the charge for another rental day including the charge for the elected equipment will be invoiced.

By the renting outside of Austria the Austrian law applies.

We only deliver the rental equipment inside of Austria. The charges refer to delivery and pick-up service from the equipment.

The rental device must be packed in the original packaging and ready for pick up.

If the shipping company has to come several times, you have to pay the developed charges.

#### **5. Cancellation**

A free cancellation is possible until one week before rental start. Otherwise you must pay 30% cancellation charges. We return the rental charges to your bank account promptly.
